

## Terms and Conditions for up to \$500 Cash Rebate SC Pay (FPS) Offer ("Offer")

- 1. The promotion period of this Offer is from 8 October 2020 to 31 October 2020 (both dates inclusive) (the "Promotion Period").
- 2. This Offer is only applicable to selected cardholders of Standard Chartered Credit Card or MANHATTAN Credit Card ("**Eligible Cards**") issued by Standard Chartered Bank (Hong Kong) Limited (the "**Bank**").
- 3. To be eligible for the cash rebate under this Offer ("**Rebate**"), selected cardholders ("**Eligible Cardholders**") who have (i) received an invitation SMS relating to this Offer directly from the Bank and (ii) successfully made a SC Pay (FPS) transfer using an Eligible Card as the debit source during the Promotion Period will be entitled to the Rebate of 2% cash rebate of the SC Pay (FPS) transfer amount, subject to a cap of HKD500 in total as a whole.
